3. The Artist, warrants and represents that they are the sole legal owner of all right, title and interest in all Artwork and has the full right and authority to enter this Agreement and grant the rights granted in this Agreement.
4. The Artist is responsible for the delivery, pack, transport, and providing for the return of their artwork and hanging the submitted artwork at their own risk and expense. Arts So Wonderful has permission to package the artwork upon same day sales and if already discussed with the artist. Arts So Wonderful is not responsible for any damage during shipment.
5. The Artist will receive 100% of their artwork sales from 4/29/22-6/25/22, but any fees put on Arts So Wonderful included with the transaction will be deducted from total profit.
6. The Artist understands that the artwork is submitted to the Arts So Wonderful Gallery and exhibited at the Artist's own risk and that neither the Arts So Wonderful Gallery nor any of its officers, agents, and employees shall be responsible for theft, vandalism, fire, or any other damages or losses to the artwork. The Artist understands and agrees that the Arts So Wonderful Gallery makes no representations or warranties regarding the level of security in the University Mall facility or premises. The Artists understands and agrees that the Arts So Wonderful Gallery and its officers, agents, and employees will not be responsible for reimbursement or replacement of lost, stolen, or damaged items and that the Arts So Wonderful Gallery does not



insure items such as the submitted artwork.

Artist shall indemnify, save and hold harmless the Arts So Wonderful Gallery, its officers, directors, employees, volunteers and agents and the participating artist from any and all claims, demands, causes of action and judgments, losses, costs and expenses, including but not limited to reasonable attorney's fees, arising due to the negligence of Artist, their employees, agents or other personnel hereunder, including but not limited to any representation, warranty, term and/or condition of this Agreement.
